**LETTER OF INTENT  
BETWEEN

The Government of the Socialist Republic of Viet Nam and the Government of the Republic of India (hereinafter referred to as "the Parties");

**Desiring** to deepen the traditional friendly relations and Comprehensive Strategic Partnership between the two countries;

**Recognising** the common interest of both countries to cooperate in the field of conservation and restoration of the Group of Temples in the World Heritage Site of My Son, Quang Nam Province, Viet Nam;

**Agreeing** with the proposal of the Government of the Socialist Republic of Viet Nam requesting India's expertise and assistance for restoration of Temples in My Son;

**Recalling** the India- Vietnam Joint Vision on Peace, People and Prosperity adopted by Prime Ministers of both countries during the Virtual Summit on 21 December 2020 and the Memorandum of Understanding regarding the Conservation and Restoration of the World Heritage Site of My Son, Quang Nam Province, Viet Nam signed by both Parties on 28 October 2014.

**Noting** the completion of restoration and conservation of A, H & K Group of Temples in cooperation between the two Parties in December 2022.


Affirm their intent to pursue the following objectives, subject to laws and regulations of the Parties and contingent upon the availability of appropriate resources:

- To implement measures for conservation and restoration of the F block of the Group of Temples in the World Heritage Site of My Son Sanctuary, Quang Nam Province.
- To nominate, from the Indian side, the authority, with regard to the project as the Archaeological Survey of India (ASI) and from the Vietnamese side, as the Ministry of Culture, Sports and Tourism.
- The project proposal details will be finalized through mutual consultations, and a separate MoU will be signed.
- The Parties will provide necessary facilitation to deliver the aforementioned objectives.


